ANNOUNCEMENT OF ALLOTMENT RESULTS

- The Offer Price has been determined at HK\$48.00 per H Share (exclusive of brokerage of 1%, SFC transaction levy of 0.0027% and Hong Kong Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$48.00 per H Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting commissions, the incentive fees and other estimated expenses in connection with the Global Offering and assuming no exercise of the Over-allotment Option, is estimated to be approximately HK\$28,031.32 million (converted from Hong Kong dollars into Renminbi at the median exchange rate published by the People's Bank of China ("PBOC") of HK\$1.00 to RMB0.78914 on December 16, 2014).
- A total of 12,077 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **White Form eIPO** Service under the **White Form eIPO** for a total of 159,490,000 Hong Kong Offer Shares, equivalent to approximately 5.32 times of the total number of 30,000,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- The final number of Offer Shares under the Hong Kong Public Offering is 30,000,000 H Shares, representing 5% of the total number of Offer Shares initially available under the Global Offering.
- The Offer Shares initially offered under the International Offering have been moderately over-subscribed. The number of Offer Shares allocated to placees under the International Offering includes an over-allocation of 90,000,000 H Shares. The settlement of such over-allocation will be effected by exercising the Over-allotment Option, which will be exercisable by the Underwriter Representatives, or by market purchases in the secondary market at prices that do not exceed the Offer Price or through deferred settlement or a combination of these means.

The Company has granted to the International Underwriters the Over-allotment Option exercisable by the Underwriter Representatives from the date of the International Underwriting Agreement up to (and including) the date which is the 30th day from the last day for lodging applications under the Hong Kong Public Offering (Wednesday, January 14, 2015) to require the Company to allot and issue up to an aggregate of 90,000,000 additional H Shares representing 15% of the initial Offer Shares under the Global Offering at the Offer Price to cover, among other things, over-allocations in the International Offering. Such conditions have been satisfied as at the date of this announcement. The H Shares placed to Ms. Chen's nominee company will not be counted as part of the public float under Rule 8.24 of the Listing Rules.

6,700,000 H Shares, representing approximately 0.15% of the Company's total issued share capital immediately following the Global Offering (before the exercise of the Over-allotment Option), were placed to Linking Wise Investment Co., Ltd. ("Linking Wise"), a "close associate" of an existing Shareholder. We have applied to the Hong Kong Stock Exchange for, and the Hong Kong Stock Exchange has granted us, a waiver from strict compliance with Rule 10.04 of the Listing Rules and Paragraph 5(2) of the placing guidelines for equity securities as set out in Appendix 6 to the Listing Rules (the "Placing Guidelines") to permit the proposed investment by Linking Wise, subject to the conditions disclosed in the section titled "Waivers from Strict Compliance with the Listing Rules — Proposed investment by a "close associate" of an existing Shareholder" in the Prospectus. Citibank N.A. is in the same group of companies as Citigroup Global Markets Asia Limited and Citigroup Global Markets Limited (collectively, "**Citi**"), two of the Joint Bookrunners and Joint Lead Managers, therefore is a connected client of Citi within the meaning of the Placing Guidelines.
